Everything's An Argument Ch. 5: Fallacies Of Argument Either/or (False Dilemma) A Fallacy Of Argument In Which A Complicated Issue Is Misrepresented As Offering Only Two Possible Alternatives, One Of Which Is Often Made To Seem Vastly Preferable To The Other Example: Either You Go On A Balanced Diet, Or You'll Die Before You're 50.
