3. Patient Images Produced For The Purpose Of Internal Education Should Be De-identified To The Extent Reasonably Possible. If The Image Cannot Be De-identified, All Facial Identifiers Should Be Removed (e.g., Identifiers Such As Patient Name, Medical Record Number And Date Of Birth Should Be Removed Or Redacted/blocked Out, Facial Images May 8th, 2024
