ISO is divided into 10 sections, with 36 objectives. Each objective is again divided into sub-objectives. The upside of using ISO 17799 for information security management systems (ISMS) is that it provides a structured approach to managing information security risks. This can help organizations to identify and assess their risks, and to implement controls to mitigate them. Additionally, ISO 17799 provides a common framework for information security management, which can help organizations to improve their security posture and to demonstrate compliance with regulatory requirements.
