9. Find a unit vector in  $\mathbb{R}^2$  that is orthogonal to  $\begin{pmatrix} 1 \\ 2 \end{pmatrix}$ . Solution: We want to find a vector  $\vec{v} = \begin{pmatrix} v_1 \\ v_2 \end{pmatrix}$  such that  $\vec{v} \cdot \begin{pmatrix} 1 \\ 2 \end{pmatrix} = 0$ . Evaluating this dot product gives the equation  $v_1 + 2v_2 = 0$  so  $v_1 = -2v_2$ . Thus, any vector of the form  $\vec{v} = \begin{pmatrix} -2 \\ 1 \end{pmatrix}$  is orthogonal to  $\begin{pmatrix} 1 \\ 2 \end{pmatrix}$ . Let us take Jan 6th, 2024
